



Parenting Under Two Roofs[©] is a four-hour educational program by **Children's Home Society of NC** that offers important tips on how to effectively Co-parent after a parental break up, whether separated, divorced or never married. Special attention is paid to understanding children's reactions and emotional needs, as well as actions parents can take to reduce conflict and build more positive communication to protect their child's wellbeing. This program is also appropriate for grandparents, stepparents, and caregivers.

HOW TO REGISTER:

Payment is required at time of registration. Registration Forms and additional information are also available at <u>Upcoming</u> <u>Events – Children's Home Society of North Carolina (chsnc.org)</u> This course is currently only available online via Microsoft Teams at this time. Program fees are \$40 per person and are paid upon registration.

1.REGISTER BY MAIL WITH CHECK OR MONEY ORDER: Complete the Registration Form, remove and mail it with a \$40 check or money order at least 10 days before the class. <u>Make checks payable</u> to Children's Home Society of NC. 3. REGISTER OVER THE PHONE: Please call the office at **336.553.1281**. You will need to recite your information that is requested on the Registration Form over the phone and your credit card information to be registered. We accept Visa, MasterCard, Discover and American Express.

4. ONLINE REGISTRATION: You may complete registration online via our website <u>www.chsnc.org</u>. The link is also provided below. To register you must select a class from the online event calendar and proceed to purchase a ticket or the event. <u>During checkout you MUST add your opposing party's name in the note section</u>. This information **MUST** be included before proceeding to checkout.

Why should I come? Children are affected tremendously by the actions that parents take before, during and after separation and during the conflicts that may result. Equipped with information from the workshop, parents can take many proactive steps to help their children, to shield them from conflict, and help them better adjust.

When should I attend? The earlier in the process you attend, the more you and your children will benefit. Many participants who have been divorced for years also find the program useful for offering tips on how to deal with their children's changing development and new situations that co-parents face. When you are mandated to complete the course is a question for your attorney or the courthouse.

Is this mediation? No. This is separate from mediation. You will need to contact the court or your attorney for information about mediation. Most clients find this course helpful in the mediation process when they have completed it prior to mediation.

Do l attend with who l am going against in court (opposing party?) We have found, after years of experience, that the program is much more useful if opposing parties attend different sessions. You will find you have more freedom to speak up or ask questions important to you. During registration, all possible precautions are taken to ensure that parents attend separate sessions. Opposing parties are not permitted to attend the same session(s).

Are children allowed to attend? Adults attend Parenting Under Two Roofs[©] to learn more about how to best support children. No children of any age are permitted to attend.

Are you part of the courts? No. We are a nonprofit agency which provides a variety of parent education programs.

Reschedule, cancel registration, or did not show for class:

- Cancellations must be made 24 hours prior (before 10:00 a.m. the day before) or fee is forfeited. .
- You may change your registration date with no extra charge, if there is at least a 24 hour notice or if there are extenuating circumstances.
- Returned check fee is \$35.

Should we come if we were never married? Yes. From a child's point of view, most of the challenges of separation are similar whether parents were married or not.

Who are the presenters? Each program is presented by a mental health professional.

Are interpreters present? At this time, the program is only offered in English. When registering, please provide your interpreter's name. The interpreter will not be charged a registration fee and will not receive a certificate of completion. A name must be provided before the class occurs. We appreciate your assistance.
