

Your Case Against Your Spouse's Paramour

You are potentially asking us to be engaged in an Alienation of Affection and Criminal Conversation case on your behalf. Enclosed, please find the jury instructions for Alienation of Affection, Criminal Conversation, and Punitive Damages that would be read to the jury at the end of the case, if tried.

Our experience shows that each point of these jury instructions needs to be corroborated and supported in three different ways at minimum. If this is on-going conduct we recommend a minimum of three nights of surveillance by a private investigator.

One of the costs that you will incur if this case goes to trial is a mock trial run by our office.

We have also enclosed a questionnaire in this packet. We will need to weigh your evidence, both pro and con, for the purpose of making a recommendation on whether your claims should be filed with the court.

23.	Has your spouse been involved with other affairs?
24.	Will your spouse accuse you of affairs?
25.	Do you have cards from your spouse? (Valentines Day, etc.)
26. video	Have you obtained documentary evidence of the affair? Letters, emails, pictures, os, cards, credit card bills, hotel records, etc? Please describe.
